

## **Induction Lighting Limited Warranty**

NEPTUN Light, Inc. ("NEPTUN"), 13950 Business Center Dr, Lake Forest, IL 60045 warrants that its Induction Light Sources/ Ballasts (retrofit kit) and Self Ballasted Induction Bulbs will be free from defect in material and workmanship from the date of installation for 5 years.

This warranty is conditioned upon proper storage, installation, use and maintenance. This warranty is not applicable to any Neptun induction lighting products which are not installed and operated in accordance with the current edition of The National Electric Code (NEC), the Standards for Safety of Underwriters' Laboratories, Inc. (UL), the Standards of the American National Standards Institute (ANSI), and with NEPTUN's instructions and guidelines for the induction system. This warranty is not applicable to any Neptun induction lighting products subjected to abnormal stresses and operating condition.

NEPTUN shall correct any defects, at NEPTUN's option, by either repairing any defective part or parts or by replacing any defective part or parts or by making available a new replacement part at no charge.

The conditions of any tests concerning any Neptun induction products which are claimed to have not performed to this warranty shall be mutually agreed upon in writing and NEPTUN shall be notified of, and may be represented at any such tests. This express limited warranty is extended by NEPTUN only to the original or first end-user purchaser.

This warranty is valid only if registered by end-user, purchaser, upon receipt by NEPTUN of the WARRANTY REGISTRATION FORM with specific information about the induction lighting system installation. Product Warranty only valid once invoice is paid in full according to terms.

NO IMPLIED STATUTORY WARRANTY OF
MERCHANTABILITY OR FITNESS FOR A PARTICULAR
PURPOSE SHALL APPLY BEYOND THE AFOREMEN-

TIONED WARRANTY PERIOD. The foregoing warranty is exclusive of all other statutory, written or oral warranties, and no other warranties of any kind, statutory or otherwise, are given or herein expressed. This warranty sets forth NEPTUN's responsibilities regarding the Neptun induction lighting system and claimant's exclusive remedy.
